

Terms and Conditions

1. PPC has to purchase goods, worth Rs. 1 lakh to start the Centre and has to maintain a minimum stock level, as may be prescribed, of Company's all Products including marketing tools & literature.
2. PPC has to pay a sum of Rs. 10,000 to the company as a security deposit. This amount is totally interest free and is refundable at the time of surrendering the PPC to the company's Head Office (HO).
3. PPC will get commission on its monthly net sales/turnover (D.P basis) on repurchase and on product package as per company policy.
4. TDS, if applicable, will be deducted as per Income Tax Act 1961.
5. PPC has to maintain proper books of accounts & records. PPC has to submit the details of all sales, closing stock statements to the H.O. every fortnight.
6. Every transaction between the PPC and the company has to take place either by way of Demand Draft or by way of advanced deposit in the Company's bank account.
7. The goods shall be dispatched by Standard Transport Service within 15 days of receiving the purchase order along with advance payment. Special Transport Service can be provided at the request & at the cost of PPC Holder. The Company shall not be responsible for delay in delivery of goods due to any reason whatsoever and will not be liable to pay any kind of claim in this regard.
8. PPC has to submit to the H.O. a copy of Income Tax, Sales Tax and other tax returns, challans & other relevant documents duly certified from a practicing Chartered Accountant for the first financial year and for all the financial years thereafter.
9. PPC has to submit a certified copy of C.S.T. Number Card, L.S.T. (TIN card) and PAN Card to the company.
10. The goods shall be delivered at PPC's city. Local Taxes, if any, shall be paid by the PPC and shall be reimbursed by the company later on.
11. PPC should display all relevant & latest information about the company's meeting, seminars and other business related details at the premises.
12. The Shop/Centre/PPC's premises should be in proper & good condition. PPC shall maintain cleanliness and proper lighting at its premises. Any damage to the goods due to improper handling & improper infrastructure at the premises shall be on PPC holder's account.
13. PPC should provide hospitality & amenities for the visitors at premises and at the meeting venue.
14. PPC should attend all the programmes/meetings organized at PPC's area of operation and at company's HO from time to time, as may be prescribed by the company.
15. PPC application has to be sponsored by two Senior Team Members.
16. The company will provide banners, name board, computer hardware, furniture layout & promotional material etc to the PPC, but the cost for these items shall be borne by the PPC.
17. If the PPC is found working against the interest of the company, the company reserves the right to take suitable action against the PPC and can also forfeit the security deposit amount of Rs. 10,000/-.
18. PPC has to submit a copy of Ration card/driving license/voter ID card/ PAN card (any two) & 2 passport size photographs with the application form for all identifications. A photo of the proposed premises is required.
19. The agreement is for one year only and is renewable at a fee as may be prescribed. This PPC is non-transferable and no change in constitution is allowed without prior approval of the company. The company reserves all the rights in this regard.
20. The company reserves all the rights to accept/reject this application without assigning any reason whatsoever.
21. Subject to Surat jurisdiction only.
